WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100- - - - - DOLLARS (\$10,000.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the Northern side of National Highway, in the City of Greenville, being shown as the Western one-half of lot 4, on plat of Croftstone Acres, recorded in Plat Book E at Pages 33 to 36, and described as follows:

"BEGINNING at an iron pin on the Northern side of National Highway at the joint front corner of lots 3 and 4, and running thence with line of lot 3, N. 12 W. 241 feet to an iron pin at corner of lot 14; thence with the rear line of lot 14, N. 67 E. 100 feet to pin; thence S. 12 E. 252 feet to a pin on National Highway; thence with the Northern side of said Highway in a Westerly direction 100 feet to the point of beginning."
