We, Herbert Campbell and Lucille Doggett Campbell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand and No/100- - - - - DOLLARS (\$ 7000.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being shown as lots 77, 78 and 79, on plat of College Heights, made by Dalton & Neves, recorded in Plat Book P at Page 75, and described as follows:

"BEGINNING at an iron pin on the South side of Erskine Street, at the joint front corner of lots 79 and 80, and running thence with said street, S. 56-50 W. 257 feet to an iron pin on the line of East Lake property; thence along the line of said property, S. 53-26 E. 280.4 feet to a Beech tree; thence N. 39-40 E. 156.8 feet to an iron pin; thence N. 40-10 W. 64 feet to an iron pin; thence N. 69-29 E. 19.6 feet to an iron pin; thence N. 33-10 W. 157 feet to the beginning corner."
