We, Kenneth E. Fryfogle and Mrs. Norma W. Fryfogle

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ninety-Six Hundred and No/100- - - - - DOLLARS (\$ 9600.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Tallulah Drive, in the City of Greenville, being shown as lot 31 on plat of property of Estate of D. T. Smith, made by Dalton & Neves in May 1935, recorded in Plat Book F, at Page 279, and described as follows:

"BEGINNING at a stake on the South side of Tallulah Drive 300 feet West from Ioka Street, at corner of lot 33, and running thence with line of said lot, S. 25-20 E..200 feet to a stake at corner of lot 32; thence with line of said lot, S. 64-40 W. 100 feet to a stake at corner of lot 29; thence with line of said lot, N. 25-20 W. 200 feet to a stake on Tallulah Drive; thence with the Southern side of Tallulah Drive, N. 64-40 E. 100 feet to the beginning corner. Being the same premises conveyed to the mortgagors by Warren B. Rogers by deed recorded in Volume 385 at Page 391."
