Dollars (\$ 9700.00), with interest from date at the rate of
four per centum (4 %) per annum until paid, said principal and interest being payable
at the office of C. Douglas Wilson & Co.
in Greenville, S. C. , or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty-one and 21/100
Dollars (\$ 51.21), commencing on the first day of
December , 19 51 , and continuing on the first day of each month thereafter until the principal and

in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville
State of South Carolina;

All that certain piece, parcel or lot of land, with the buildings and improvements
thereon, lying and being on the Northwesterly side of Wedgewood Drive, near the City
of Greenville, South Carolina, being shown as Lot No. 20 on the plat of North
Meadow Heights as recorded in the RMC Office for Greenville County, S. C., in Plat
Book "W", page 183, said lot fronting 70 feet on the Northwesterly side of Wedgewood
Drive and having a depth of 182.8 feet on the Southwesterly side, a depth of 182.5
feet on the Northeasterly side and being 70 feet across the rear.
