(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Five Hundred and No/100- - - - - DOLLARS (\$ 4500.00 ), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville, Township, on the Western side of Conestee Avenue, near the City of Greenville, being shown as lot 37, on plat of South Cherokee Park, made by J. P. Willis, Surveyor, July 1, 1908, recorded in Plat Book A at Page 130, and described as follows:

"BEGINNING at a stake on the Western side of Conestee Avenue, 180 feet South from Saluda Street at corner of lot 36, and running thence with the line of said lot, N. 63-00 W. 172-3/4 feet to stake on a 15 foot alley; thence with said alley, S. 27-00 W. 60 feet to a stake, corner of lot 38; thence with the line of said lot, S. 63-00 E. 173 feet to a stake on Conestee Avenue; thence with the Western side of Conestee Avenue, N. 27-00 E. 60 feet to beginning corner."

Being the same premises conveyed the mortgagor by Joseph O. and Ruby A. Bolt by deed to be recorded herewith.
