To ALL WHOM THESE PRESENTS MAY CONCERN: We, Douglas W. Craft and Marion A. Craft of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto General Mortgage Co.

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Seventy-six Hundred Dollars (\$ 7600.00), with interest from date at the rate of four & one-fourth per centum ($4\frac{1}{4}$ %) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, S. C., or at such other place as the holder of the note may designate in writing, in monthly installments of Forty-seven & twelve one-hundredths Dollars (\$47.12), commencing on the first day of January, 19 52, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 1971 .

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 7 of Hillside Terrace, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in plat book F at page 154 and having according to a more recent survey made by R. W. Dalton, Engineer, the following metes and bounds to-wit:

Beginning at an iron pin on the north side of Cleveirvine Avenue (formerly Hillside Avenue), the joint corner of lots No. 5 & 7, and running thence with the joint line of said lots N. 20-51 E. 121.6 ft. to an iron pin; thence S. 86-13 E. 58 feet to an iron pin corner of lot No. 9; thence with the line of said lots S. 17-44 W. 123 feet to a point (drill hole) on the north side of Cleveirvine Avenue; thence with the north side of said Avenue N. 84-04 W. 64.3 feet to the beginning corner.
