WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest, Travelers Rest, S.C.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Three Hundred Twenty-Six & 99/100

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$20.00 on December 30, 1951, and a like payment of \$20.00 monthly thereafter until paid in full, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid semi-annually in advance.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, on the Northern side of Sulphur Springs Road, and described as follows:

"BEGINNING at a point in the center of Sulphur Springs Road, 972 feet West from Old Buncombe Road, and running thence with other property of the said Annie N. Stansell, N. 2-30 W. 210 feet to a point in line of Tract 2; thence with the joint line of Tracts Nos. 1 and 2, S. 88-30 W. 78 feet to a point; thence S. 2-30 E. 210 feet to a point in the center of Sulphur Springs Road; thence with the center of said road, N. 87-30 E. 78 feet to beginning."
