MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

SEND GREETING:

WHEREAS, I the said Fleming H. Boyd '

I. Fleming H. Boyd, of Greenville County,

in and by my certain promissory note, in writing, of even date with these presents are well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the

full and just sum of Eight Thousand and No/100 - - - - - - - - - - - (\$ 8,000.00)

Dollars, with interest at the rate of $\sin x/(6\%)$ per centum per annum, to be repaid in instalments of

Forty-Eight and 48/100 - - - - - - - - (\$ 48.48) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note farther providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN. That I, the said Fleming H. Boyd

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-

cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the North side of Vanderbilt Circle, being known and designated as Lot No. 43 of White Oak Subdivision of Northside Development Company, and being more particularly described according to a plat prepared by J. D. Pellett, Jr. in August, 1946, and recorded in the R.M.C. office for Greenville County in Plat Book P, at page 121, and having the following courses and distances, to-wit:

"BEGINNING at a stake on the Northside of Vanderbilt Circle, joint front corner of Lots Nos. 42 and 43, and thence running with line of Lot No. 42, N. 19-11 W. 193.1 feet to a stake on the rear line of Lot No. 37; thence with the rear line of Lot No. 37, S. 63-29 W. 38 feet to a stake at the common corner of Lots Nos. 43, 37, 36, 48 and 47; thence with the rear line of Lot No. 47, S. 23-58 W. 76.8 feet to a stake at the joint rear corner of Lots Nos. 43 and 44; thence with the line of Lot No. 44, S. 23-57 E. 147.8 feet to a stake on the Northside of Vanderbilt Circle; thence with Vanderbilt Circle, N. 58-30 E. 80 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
