SEND GREETING:

Whereas, I, the said Walter J. Collins
in and by my certain Promissory note in writing, of even date with these
Presents, am well and truly indebted to John Chiles
in the full and just sum of Five Hundred Fourteen and No/100 (\$514.00) Dollars
to be paid according to terms of note of even date

with interest thereon from date
at the rate of six per centum per annum, to be computed and paid semi-annual ly
until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

all that piece, parcel or lot of land being known and designated
as Lot No. 92 of Conestee in Gantt Township, Greenville County, State
of South Carolina as shown by a plat thereof, made by R. E. Dalton,
Engineer, dated December, 1943, and recorded in the R. M. C. office
for Greenville, S. C. in Plat Book K, Page 276 and according to said
plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at corner of Fifth Street and Third
Avenue and running thence with said Fifth Street S. 42-40 W. 96 feet
to an iron pin corner of Lot No. 91; thence along the line of Lot No.
91 S. 46-20 E. 150 feet to an iron pin in line of Lot No. 93; thence
along the line of said lot N. 42-40 E. 104 feet to an iron pin on
Third Avenue; thence along said Avenue N. 49-25 W. 150 feet to the
