TO ALL WHOM THESE PRESENTS MAY CONCERN: **I, C. W. McClimon**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - - - -

Twenty-six Hundred and no/100 - - - - -
DOLLARS (\$ **2600.00**), with interest thereon from date at the rate of **six**

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents, does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

O'Neal Township, about 1½ miles N.E. of Greer, known and shown as Lot No. 18 on plat of the B. H. Burnett property, prepared by J. Q. Bruce, 2-6-50, recorded in Plat Book X, page 119, reference to which plat is hereby made for a more complete and detailed description. According

to said Plat, Lot No. 18 has the following courses and distances, to-wit:-
Beginning on the south side of the Old C.C. Camp Road, the joint front corner of Lots 18 and 19, and runs thence as dividing line between said Lots S 33-36 W 267 feet to iron pin on rear line of Lot 29; thence S 88 W 86 feet to iron pin; thence dividing Nos. 18 and 17 Lots N 33-36 E 317 feet to said Road; thence therewith S 56-3 ¼ E 70 feet to the beginning.
