"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, all that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, and in the town of Mauldin, and more fully described as follows:

BEGINNING at an iron pin 496.8 feet east of the C & W C Railroad and same distance from joint corner of property of Jim Willis Whitt and Mauldin High School property and running thence N. 24-06 W. 301.5 feet to an iron pin on an unnamed street; thence along the southern side of said unnamed street, N. 60-15 E. 80 feet to an iron pin to corner of property heretofore sold by grantor to Ben Adams; thence along line of Ben Adams property, S. 24-06 E. 301.5 feet to an iron pin on line of Mauldin High School property; thence along line of Mauldin School property, S. 60-15 W. 80 feet to the beginning corner, and being a portion of the property conveyed to me by Jesse A.
