"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Eastern side of Wilton Street and being more particularly described as follows:

"BEGINNING at a point on the Eastern side of Wilton Street, corner of lot conveyed by C. M. McGee to J. A.
