(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter-referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eighty-Five Hundred and No/100- - - - - DOLLARS (\$ 8500.00 ), with interest thereon from date at the rate of Five (5) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast side of Carmell Street, being known and designated as lot 72, Block E, as shown on revised plat of University Heights, to be recorded in Plat Book 18 at Page 21, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southeast side of Carmell Street, which pin is 103 feet from the Southeast intersection of Carmell Street and Corrine Drive, and is the joint front corner of lots 72 and 73, and running thence with joint line of said lots, S. 28-30 E. 110 feet; thence N. 56-37 E. 103 feet to joint rear corner of lots 71 and 72; thence with joint line of said lots, N. 28-30 W. 100 feet to iron pin on Southeast side of Carmell Street; thence with said street, S. 56-37 W. 110 feet to the point of beginning."
