WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of FIVE THOUSAND AND NO/100 - - - - - DOLLARS (\$ 5,000.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwest side of Beth Drive (formerly known as Elizabeth Drive) shown as Lot 56 on plat of North Sunset Hills, made by Dalton & Neves, Engineers, July 1940, recorded in the R. M. C. office for Greenville County, S. C., in Plat Book "L", at page 92, said lot fronting 60 feet along the Northwest side of Beth Drive, running back to a depth of 182.5 feet on the Northeast side, to a depth of 169.2 feet on the Southwest side and being 64 feet across the rear.

This is the same property conveyed to the Mortgagor by deed of Robert W. Wade, dated May 21, 1949, recorded in the R. M. C. office for Greenville County, S. C., in Deed Book 382, at page 376.
