hereinafter spoken of as the Mortgagor send greeting.

Whereas ----- Robert L. Waldrop, Jr., same as Robert L. Waldrop -----  
is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the  
State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of -----

----- Eleven Thousand Three Hundred and No/100----- Dollars

(\$ 11,300.00 -----), lawful money of the United States which shall be legal tender in payment of all  
debts and dues, public and private, at the time of payment, secured to be paid by that one certain bond  
or obligation, bearing even date herewith, conditioned for payment at the principal office of the said  
C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without  
the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of

----- Eleven Thousand Three Hundred and No/100----- Dollars (\$ 11,300.00 -----)

with interest thereon from the date hereof at the rate of  $4\frac{1}{2}$  ----- per centum per annum, said interest  
to be paid on the ----- 1st ----- day of ----- April ----- 19 52 and thereafter said interest  
and principal sum to be paid in installments as follows: Beginning on the ----- 1st ----- day  
of ----- May ----- 19 52, and on the ----- 1st ----- day of each month thereafter the  
sum of \$ 71.50 ----- to be applied on the interest and principal of said note, said payments to continue  
up to and including the ----- 1st ----- day of ----- March -----, 1972, and the balance  
of said principal sum to be due and payable on the ----- 1st ----- day of ----- April -----, 19 72;  
the aforesaid monthly payments of \$ 71.50 ----- each are to be applied first to interest at the rate

ever, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and  
being in the City of Greenville, County of Greenville, State of South Carolina,  
being known and designated as Lot No. 152, Cleveland Forest, as per plat thereof  
recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat  
Book M, page 57; said lot having a frontage of 60 feet on the Eastern side of  
Trails End, a depth of 159.4 feet on the North, a depth of 159.4 on the South  
and 60 feet across the rear.
