NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

Godfrey Webster, recorded in Plat Book Z at Page 141, and described as follows:**

"BEGINNING at a stake on the Southern side of Dale Drive, 498 feet Southeast from Ellison Street, at corner of lot No. 19 and running thence with the line of said lot, S. 55-30 E. 160.7 feet to a stake; thence S. 30-27 W. 140 feet to a stake at corner of lot No. 22; thence with the line of said lot, N. 55-30 W. 203.7 feet to a stake on Dale Drive; thence with the Southeast side of Dale Drive, N. 47-40 E. 144 feet to the beginning corner."
