

SEND GREETINGS:

Ollie Burns Whereas. the said Ι certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to in and by HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, in the full and just sum of Six Thousand and No/100- - - - -(\$ 6000.00) payable at the offices of said Association at Easley, South Caroling with interest at the rate of fix perfecentum (6%) per annum, to be repaid in installments of thereafter the sum of Sixty & No/100 - - (\$ 60.00) Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attrorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

South Carolina, at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, its successors or assigns:

All those lots of land in Greenville County, State of South C rolina, in Greenville Township, being known and designated as a small portion of lot No. 77, and all or lots Nos. 78 and 79, as shown on a plat of City View Annex, recorded in Plat Book G at Pages 153 and 154, and being more particularly described according to a recent survey of J. C. Hill as follows:

BEGINNING at an iron pin on the South side of the Marion Road, joint front corner of lots 77 and 78, and running thence through lot No. 77, S. 30-30 E. 189.9 feet to an iron pin in rear line of said lot; thence S. 46-0 W. 104.5 feet to an iron pin, joint rear corner of lots 79 and 80; thence with joint line of said lots, N. 29 W. 236.5 feet to an iron pin in the South side of Marion Road; thence with said Road, N. 85-30 E. 12 feet to a point; thence still with said road, N. 70-30 E. 87.2 feet to the point of beginning.
