C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of

with interest thereon from the date hereof at the rate of 4 per centum per annum, ~~with interest~~

and principal sum to be paid in installments as follows: Beginning on the first (1st) day

of April 1952, and on the first day of each month thereafter the

sum of \$ 38.54 to be applied on the interest and principal of said note, said payments to continue

up to and including the first day of February, 1977, and the balance

of said principal sum to be due and payable on the first day of March, 1977;

the aforesaid monthly payments of \$ 38.54 each are to be applied first to interest at the rate

of 4 per centum per annum on the principal sum of \$ 7300.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. M. C. Office for Greenville County in plat book P page 75, and having according to a more recent survey made by R. W. Dalton, October 1951, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the southeast corner of the intersection of Princeton Avenue and a 20 ft. road, and running thence with said 20 ft. road S. 53-26 E. 186.2 feet to an iron pin corner of lot No. 64; thence with the line of said lot N. 56-50 E. 73.5 feet to an iron pin corner of lot No. 50; thence with the line of said lot N. 33-10 W. 175 feet to an iron pin on the southeast side of Princeton Avenue; thence with the southeast side of said Avenue S. 56-50 W. 137.5 feet to an iron pin, the beginning corner.
