(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Thousand, Four Hundred and Fifty and no/100 DOLLARS (\$ 11,450.00), with interest thereon from date at the rate of five per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot No. 96, Block C, according to plat of University Heights, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book Y, at page 53, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Corinne Drive, joint front corner of Lots Nos. 95 and 96 and running thence along the line of Lot No. 95, S. 58-47 W. 215.6 feet to an iron pin; thence along the rear line of Lots Nos. 43 and 44, S. 31-16 E. 100 feet to an iron pin at the rear corner of Lot No. 97; thence along the line of Lot No. 97, N. 58-47 E. 215.4 feet to an iron pin on Corinne Drive; thence along the northwestern side of Corinne Drive, N. 31-13 W. 100 feet to an iron pin at the point of beginning.
