All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, being known and designated as Lot 41 of the property of Central Development Corporation according to a plat thereof prepared by Dalton & Neves, October 1951 and recorded in the R. M. C. office for Greenville County in Plat Book BB, at pages 22 and 23, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Dellwood Drive at the joint front corners of Lots Nos. 40 and 41, and running thence along the joint line of said lots, N. 13-05 W. 216.9 feet to an iron pin on the rear line of Lot No. 37; thence along the rear lines of Lots Nos. 37 and 36, N. 39-19 E. 75 feet to an iron pin on the rear line of Lot No. 36; thence along the joint line of Lots Nos. 41 and 42, S. 19-55 E. 257.8 feet to an iron pin on the northern side of Dellwood Drive; thence along the northern side of Dellwood Drive, S 73-0 W. 90 feet to the beginning corner, being a portion of the property conveyed to Central Development Corporation by Annie E.
