TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Thomas E. Lynn,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

**Fifty-six Hundred and no/100 - - - - -**  
DOLLARS (\$ 5600.00 ), with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

lying and being on the northwestern side of Maycourt Street and being known and designated as Lots Nos. 30, 31 and 32, Block F, of Buena Vista, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "W", pages 11 and 29, and having the following metes and bounds according thereto:-

Beginning at a point on the northwestern side of Maycourt Street, joint corner of Lots Nos. 32 and 33, and running the nce as the common line of said Lots N 47-08 W 150 feet to iron pin; thence with the rear lines of Lots Nos. 15, 14 and 13, N 42-52 E 105 feet to corner of Lot No. 29; thence dividing Nos. 29 and 30 Lots S 47-08 E 150 feet to northwestern side of said Street; thence therewith S 42-52 W 105 feet to the beginning corner.

The above is the same conveyed to me this date by deed of W. R. Dill and Lewis Brown to be recorded herewith.

The above property is subject to the restrictions recorded in said R.M.C. Office in Deed Book 379, at page 230.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
