Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina: all that piece, parcel or lot of land with the buildings and
improvements thereon, situate, lying and being near the City of Greenville, in the
County of Greenville, State of South Carolina, being known and designated as Lot
No. 124, Map No. 3, Sans Souci Heights Subdivision, as per plat thereof recorded
in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Z,
page 95; said lot having a frontage of 75 feet on the Northerly side of Lenore Avenue,
a depth of 121 feet on the East, a depth of 135.4 feet on the West and 74.3 feet
across the rear.
