

over said road as it may at any time hereafter be relocated, in the event the grantors, their heirs or assigns relocate same, from the western terminus of said road where it intersects Lawndale Drive Extension, (sometimes referred to as Hillsdale Road) to the above described and conveyed property, including the perpetual right of the grantee and its successors and assigns of ingress, egress and regress across that tract of land described in Book 1108 at Page 363 in the office of the Register of Deeds of Guilford County, North Carolina, over which Lillie Webb Clarida was granted a perpetual easement by J. R. Everhart and wife, Mamie P. Everhart, and which easement was conveyed and assigned to Lewis A. Raulston and wife, Willie Burt Raulston, by that certain deed recorded in Deeds Book 1373 at Page 138 in the office of the Register of Deeds of Guilford County, North Carolina, it being the intention of the grantors herein to convey and assign to the grantee a right to use the area subject to said easement to the same extent as the grantors are entitled to use said area.

Being the same premises conveyed to the Company by Louis A. Raulston and wife Willie Burt Raulston by deed dated June 5, 1952 and recorded on June 6, 1952 in Book 1414 at page 227. Together with the rights, privileges and easements, if any, and subject to the exceptions and reservations of record affecting said premises.
