"All that certain piece, parcel, or lot of land situate, lying  
and being in the State of South Carolina, County of Greenville,  
Austin Township, in the Laurel Creek section near the Laurens  
Road, containing 2.75 acres, more or less, being a portion of  
a 96-acre tract conveyed to G. C. Franklin by James A. McDaniel  
by deed dated Feb. 16, 1906 and recorded in the office of the  
R. M. C. for Greenville County in Deed Vol. RRR, page 613, and  
having the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the Conestee Road at the  
corner of lot previously conveyed to David Valentine, and running
