WHEREAS: I, Billy W. Parsons

, hereinafter called the Mortgagor, is indebted to

**Fidelity Federal Savings & Loan Association**

organized and existing under the laws of **South Carolina**, a corporation  
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-  
porated herein by reference, in the principal sum of **Seventy-Five Hundred Fifty and No/100- - -**  
Dollars (\$7550.00), with interest from date at the rate of  
**Four- - -** per centum ( **4** %) per annum until paid, said principal and interest being payable  
at the office of **Fidelity Federal Savings & Loan Association**  
in **Greenville, S.C.**, or at such other place as the holder of the note may  
designate in writing delivered or mailed to the Mortgagor, in monthly installments of **Forty-Five and 75/100**  
Dollars (\$ 45.75), commencing on the first day of  
**September**, 19 **52**, and continuing on the first day of each month thereafter until the principal and  
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and  
payable on the first day of **August**, 19 **72**.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the  
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor  
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt  
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of **Greenville**  
State of South Carolina; on the **Southeast** side of **Dale Drive**, in the City of **Greenville**,  
being shown as lot No. 20, on plat of Property of E. Godfrey Webster, recorded in  
Plat Book Z at Page 141, and described as follows:

**BEGINNING** at a stake on the Southern side of Dale Drive, 498 feet South-  
east from Ellison Street, at corner of lot 19, and running thence with the line  
of said lot, S. 55-30 E. 160.7 feet to a stake; thence S. 30-27 W. 70 feet to a  
stake at corner of lot 21; thence with the line of said lot, N. 55-30 W. 182.2  
feet to a stake on Dale Drive; thence with the Southeast side of Dale Drive,  
N. 47-40 E. 72 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by H. C. Bates  
by deed to be recorded herewith.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances  
to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that  
the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all  
fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto  
the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty  
and are a portion of the security for the indebtedness herein mentioned;
