PARCEL - 13: All that certain tract of land in Saluda Township, Greenville County, State of South Carolina, containing 306 acres, more or less, lying and being on waters of Terry Creek and adjoining lands of E. E. Dargan and Henry L. Ware and lands now or formerly of Ella Trammell, et al; also,

All that certain tract of land in Saluda Township, Greenville County, State of South Carolina, containing 176 acres, more or less, lying and being on waters of Devils Fork Creek, adjoining lands of E. E. Dargan and Henry L. Ware and lands now or formerly of John D. Smith, et al.

These two tracts of land are fully described on the plat mentioned above as "A-XXIV, Ann J. Henderson" and as "Tract No. 1" and "Tract No. 2", respectively, reference to which plat is hereby craved for a complete and accurate description of the area, metes and bounds of said property.

PARCEL - 14: All that certain tract of land in Saluda Township, Greenville County, State of South Carolina, containing 144 acres, more or less, lying and being on waters of Devils Fork Creek, adjoining lands of E. E. Dargan and Henry L. Ware known as the "Ann J. Henderson Tract" hereinabove described, as described on the plat mentioned above as "No. A-XI, Thos. Wilson", reference to which plat is hereby craved for a complete and accurate description of the area, metes and bounds of said property.

PARCEL - 15: All that certain tract of land in Saluda Township, Greenville County, State of South Carolina, containing 216 acres, more or less, lying and being on waters of Terry Creek, adjoining lands of E. E. Dargan and Henry L. Ware, known as Tracts "Ann J. Henderson, Smythe, Haynsworth & Taylor, et al", fully described on the plat mentioned above as "No. B-VI, John H. Goodwin", reference to which plat is hereby craved for a complete and accurate description of the area, metes and bounds of said property.

PARCEL - 16: All that certain tract of land in Saluda Township, Greenville County, State of South Carolina, containing 98 acres, more or less, lying and being to the Northwest of the Public Road near the North Saluda River, adjoining lands now or formerly of W. C. Goodwin, Arthur Cox, et al, as fully described on the Wiswall plat mentioned above as "C-XVI, J. A. Thomas", reference to which plat is hereby craved for a complete and accurate description of the area, metes and bounds of said property.
