To All Whom These Presents May Concern:

SEND GREETING:

Whereas, I, the said Carl B. Holland
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to Joe H. Long
in the full and just sum of Five Hundred and no/100 (\$500.00) Dollars
to be paid six (6) months from date

with interest thereon from date
at the rate of 6% per centum per annum, to be computed and paid semi-annually
until paid in full: all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said Carl B. Holland
in consideration of the said debt and
sum of money aforesaid, and for the better securing the payment thereof to the said Joe H. Long
according to the terms of the said note, and also in
consideration of the further sum of Three Dollars, to me, the said Carl B. Holland
in hand well and truly paid by the said Joe H. Long
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said Joe H. Long,
his heirs and assigns:

All that certain piece, parcel or lot of land, with the buildings and improvements
thereon, lying and being on the Southeasterly side of Mayo Drive, near the City of
Greenville, South Carolina, being shown as Lot No. 187 on the plat of Paramount
Park as recorded in the RMC Office for Greenville County, South Carolina, in Plat
Book "W", page 57, said lot fronting 70 feet on the Southeasterly side of Mayo
Drive and having a depth of 150 feet on the Northeasterly side, a depth of 150 feet
on the Southwesterly side, and being 70 feet across the rear.

This mortgage is subordinate and junior to that certain mortgage given by Carl B.
Holland to A. W. Agnew in the amount of \$3,000.00, bearing even date herewith.
