MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Jack E. W. Galway

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Aubrey Shives

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-five Hundred & No/100 -

DOLLARS (\$ 3,500.00),

with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid: On or before 90 days after date, with interest thereon from date at the rate of 6% per annum, to be computed and paid at maturity.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Northeastern side of Sitka Avenue, in the City of Greenville, being shown as Lot No. 30 on Plat of Parkview, made by Dalton & Neves in June, 1942, recorded in Plat Book M at Page 49 and described as follows:

"BEGINNING at a stake on the Northeastern side of Sitka Avenue 161 feet northwest from Alaska Avenue at corner of Lot No. 31, and running thence with the line of said lot, N. 63-45 E. 150 feet to a stake in line of Lot No. 36; thence with the lines of Lots Nos. 36 and 37, N. 26-15 W. 50 feet to a stake, corner of Lot No. 29; thence with the line of said lot, S. 63-45 W. 150 feet to a stake on Sitka Avenue; thence S. 26-15 E. 50 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by deed recorded in Book of Deeds 316 at Page 55.

This mortgage is junior in lien to a mortgage executed by the mortgagor to Metropolitan Life Insurance Company.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
