WHEREAS, the Mortgagor is well and truly indebted unto

are incorporated herein by reference, in the principal sum of **Ninety-Three Hundred and no/100**
Dollars (\$ 9,300.00), with interest from date at the rate of **four and one-fourth** per centum
($4\frac{1}{4}$ %) per annum until paid, said principal and interest being payable at the office of
General Mortgage Co. in **Greenville, S. C.**
or at such other place as the holder of the note may designate in writing, in monthly installments of
Fifty-Seven and 66/100 Dollars (\$ 57.66),
commencing on the first day of **October**, 19 **52**, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of **September**, 19 **72**.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of **Three**
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of **Greenville**,
State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the Southerly side of Meyers Drive (formerly
Marietta Street), in the City of Greenville, South Carolina, being shown as Lot No.
30 on the plat of Rockwood Park as recorded in the RMC Office for Greenville County,
S. C. in Plat Book "S", pages 168 and 169, said lot fronting 75 feet on the Southerly
side of Meyers Drive (formerly Marietta Street), and having a depth of 175 feet on
the Easterly side, a depth of 175 feet on the Westerly side, and being 75 feet across
the rear.
