BEGINNING at a point in the center of a road, corner of property now or formerly of Welborn, and running thence with the line of said property N. 80½ E. 2.60 chs. to a point, corner of Turner land; thence with the line of said land in a northerly direction 3.15 chs to iron pin, corner of Reese property; thence with the line of said property S. 88 W. 3.5 chs to a point in center of said road; thence with the center of said road in a southerly direction 3.5 chs to the beginning corner.
