C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100---

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Merlock Drive, in the City of Greenville, being known and designated as lot No. 7 on plat of property of Jean Lockerbie Brooks, made by J. Coke Smith October 1946, recorded in Plat Book Q at Page 47, and described as follows:

"BEGINNING at an iron pin on the Eastern side of Merlock Drive, joint front corner of lots 6 and 7, and running thence with line of lot 6, N. 53-45 E. 157 feet to an iron pin; thence N. 36-15 W. 60 feet to an iron pin in line of other property of Merle Louise Rodgers; thence with line of that property and that of Jean Lockerbie Brooks, S. 53-45 W. 157 feet to an iron pin; thence S. 36-15 E. 60 feet to the point of beginning."
