NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Bishop Street, being known and designated as lots Nos. 59, 61, and 63 as shown on plat of property of H. B. Bates recorded in Plat Book F at Page 32, and described as follows:

"BEGINNING at an iron pin in the South side of Bishop Street, which pin is 250 feet Northeast of the intersection of Bishop Street and Center Street, and is the joint front corner of lots 57 and 59, and running thence with joint line of said lots, S. 48-30 W. 142.5 feet to an iron pin, rear corner of lot 58; thence with rear line of lots 58, 60 and 62, S. 55-40 E. 150 feet to iron pin in rear line of lot 66; thence with rear line of lots 66 and 67, N. 48-30 E. 142.5 feet to iron pin in Southern side of Bishop Street; thence with said Street, N. 55-40 W. 150 feet to the point of beginning."
