C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor—in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, on the West side of U. S. Highway No. 29 and being known and designated as Lots Nos. 34 and 35 of the T. D. Bennett sub-division, as shown by plat made by G. Sam Lowe, Registered C. E., dated August 24, 1948 and recorded in R. M. C. Office for Greenville County in Plat Book S, page 143, and according to said plat more particularly described as follows:-

Manufacturing Company on the northern side of Bennett Street and running thence N. 81-55 E with the northern edge of Bennett Street 75 feet to the joint corners of Lets Nos. 35 and 36; thence N. 0-50E 335 feet to the joint corners of Lots Nos. 35 and 36; thence N 89-15 W 150 feet to the joint back corners of Lots Nos. 77 and 78; thence S 12-20 E 355 feet to the beginning corner.
