"BEGINNING at an iron pin on the Southwest side of Bates Avenue, joint front corner of Lots No. 12 and 13, said pin also being 462.6 feet in a Northwesterly direction from the point where the Southwest side of Bates Avenue intersects with the Northwest side of Webster Road, and running thence with the line of Lot No. 13, S. 53-47 W. 170 feet to an iron pin; thence N. 36-13 W. 50 feet to an iron pin; thence with the line of Lot No. 11, N. 53-47 E. 170 feet to an iron pin on the Southwest side of Bates Avenue; thence with the Southwest side of Bates Avenue, S. 36-13 E. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to us by R. K. Taylor by his deed dated June 24, 1941, recorded in the R. M. C. office for Greenville County in Vol. 234, at page 313."
