, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Six Thousand Dollars (\$6,000.00), with interest from date at the rate of Four & one-fourth per centum (4 1/4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S.C. or at such other place as the holder of the note may designate in writing, in monthly installments of Thirty-seven and 20/100 Dollars (\$37.20), commencing on the first day of December, 1952, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of November, 1972.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain parcel or lot of land situated on the North side of Mountain View Avenue and the East side of an alley in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, being the greater portion of Lot No. 16 of the Property of W. Dennis Smith and H.J. Waters, plat thereof recorded in Plat Book "Y", page 69, R.M.C. Office for Greenville County, and being particularly designated and shown as the Property of Marvin C. Dacus according to survey and plat thereof by H.S. Brockman, Registered Surveyor, dated October 7, 1952, recorded in Plat Book "T", page 461, R.M.C. Office for Greenville County, and having a frontage of 70 feet on Mountain View Avenue, a depth of 179 feet on the East side, a width of 68.7 feet on the rear line, and a depth of 167.4 feet on the West side and along the alley.
