Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina: in the City of Greenville, on the Northwest side of Buena Vista Street, being known and designated as lot No. 121, Black A, as shown on a plat of University Heights, recorded in Plat Book Y at Page 53, and being more particularly described according to a recent survey of J. C. Hill as follows:

REGINNING at an iron pin in the Northwest side of Buena Vista Street, joint front corner of lots 120 and 121, which pin is 250.5 feet Southwest from the intersection of Buena Vista Street and Karen Drive, and running thence with Buena Vista Street, S. 58-10 W. 100 feet to an iron pin, corner of lot 122; thence with line of said lot, N. 31-50 W. 172.7 feet to an iron pin; thence N. 49-28 E. 101.2 feet to an iron pin, rear corner of lot 120; thence with line of said lot, S. 31-50 E. 188 feet to the point of beginning.
