To All Whom These Presents May Concern: I, Donald E. Baltz

SEND GREETING:

Whereas, I, the said Donald E. Baltz hereinafter called the mortgagor(s) in and by my certain promissory note in writing, of even date with these presents, am well and truly indebted to W. W. Wilkins hereinafter called the mortgagee(s), in the full and just sum of Five Thousand - - DOLLARS (\$ 5000.00), to be paid six months from date

, with interest thereon from date at the rate of six (6%) percentum per annum, to be computed and paid

semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, being known and designated as lot No. 11 of property of Donald E. Baltz as shown on plat prepared by Dalton & Neves, September 1951, recorded in plat book Y page 46, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Don Drive, the joint corner of lots No. 11 & 12 and running thence with the joint line of said lots S. 32-07 W. 150 feet to an iron pin in line of lot No. 26; thence with the line of said lot N. 57-53 W. 39.5 feet to an iron pin; thence N. 1-30 W. 180 feet to an iron pin on the southwest side of Don Drive; thence with the southwest side of said Drive S. 57-53 E. 139.2 feet to the beginning corner.
