interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

**Farmers Bank of Simpsonville, its successors or assigns:- All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the northwest side of the Georgia Road in the Town of Simpsonville, adjoining lands of Waymond Hart, Geo. Barnett etal, and being more fully described as follows:**

**Beginning at a point in the center of Georgia Road, Harts corner, and running thence along Harts line N. 7-20 W. 293.6 ft. to an iron pin on Barnett line; thence along Barnett line S. 65-16 W. 106.6 ft. to an iron pin; thence S. 7-20 E. 294.6 ft. to point in center of Georgia Road; thence along said road N. 73-13 E. 76 ft. to bend; thence further along said road N. 48-36 E. 33.2 ft. to the beginning corner and being the same lot conveyed to mortgagor by J.
