WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Three Thousand and No/100--- Dollars (\$ 3,000.00 ), with interest from date at the rate of four & one-quarter per centum ( 4 1/4 % ) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. C., or at such other place as the holder of the note may designate in writing, in monthly installments of Eighteen and 60/100 - - - - - Dollars (\$ 18.60 ), commencing on the first day of February, 19 53, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 19 73.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate on the southwest side of Gladys Drive, near the City of Greenville, in Greenville County, S. C., shown as Lots Nos. 42, 43, 44, 45, 46 and 47, on plat of Glad Acres, made by Pickell & Pickell, Engineers, dated April 15, 1946, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book S, at Page 13, said lots together having a frontage of 282.3 feet along the southwest side of Gladys Drive, running back to a depth of 321.1 feet along the southeast side, to a depth of 254.3 feet on the northwest side and being 417.6 feet across the rear.
