and the balance of \$25.00 on the 19th day of June, 1953

, with interest thereon from date

at the rate of seven (7%) percentum per annum, to be computed and paid

monthly until paid in full; all interest not paid when due to bear  
interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole  
amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose  
this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, be-  
fore its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder  
should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases  
the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be  
added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I, the said mortgagor(s), in consideration of the said debt and sum of money aforesaid,  
and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in con-  
sideration of the further sum of Three Dollars, to me, the said mortgagor(s), in hand well and truly paid by the said mort-  
gagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and  
released and by these Presents do grant, bargain, sell and release unto the said Claude I. Campbell,

All that piece, parcel or lot of land in Greenville Township, Green-  
ville County, state of South Carolina, being known as Lot No. 14 on the  
plat of property of Harry H. Palm made by W. J. Riddle, Surveyor, in  
May, 1946 and recorded in the R. M. C. Office for Greenville County in  
Plat Book B, page 84, being more particularly described as follows:

Beginning at the joint corner of Lots Nos. 13 and 14 on Poplar Street;  
thence S. 11-30 W. 60 feet to the joint corner of Lots Nos. 14 and 15;  
thence N. 67-15 W. 210 feet to a point in the middle of the branch; thence  
in a northeasterly direction with the course of said branch 59.3 feet  
more or less to a point in the middle of said branch at the joint corner  
of Lots Nos. 13 and 14; thence S. 67-15 E. 212 feet to the beginning  
corner on Poplar Street.
