SEND GREETING:

Whereas, **I**, the said **S.B. Fleming**

in and by **my** certain **official** note in writing, of even date with these Presents, **am** well and truly indebted to **B.P. Edwards**

in the full and just sum of **Five thousand one hundred twenty four & 76/100~~00~~** (**5,124.76**) to be paid **\$75.00 permonth for 47 months, entire balance to be paid in full 48 months from date.**

with interest thereon from **date**

at the rate of **seven** per centum per annum, to be computed and paid **annually**

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that piece, parcel or lot of land in **Greenville County, State of South Carolina, near Paris Station, on the Northerh side of the old National Highway, and known and designated as Lots Numbers 76, 77, 78 and 79, and as shown on plat of the subdivision of the E.M. Wharton property recorded in the R.M.C. Office for Greenville County in Plat Book "F" at page 208, and described together, having the following mete and bounds, to-wit:-**

BEGINNING at an iron pin on the northern side of said old National Highway at corner of Lot No. 75 on said plat, and running thence N 60-16 E 100 feet along said Highway to corner of Lot No. 80, thence with line of said Lot No. 80, N. 29-44 W. 50 feet to an iron pin; thence S. 60-16 W. 100 feet along the line of Lot No 73 to corner of Lot No. 75; thence S. 29-44 E 50 feet along the line of Lots No 75 to the beginning corner; being the same lots of land conveyed to me by Wm.
