All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the west side of Jones Avenue in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 33 a plat of Crescent Terrace made by R. E. Dalton, Engineer, July , 1919, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "E", Page 137, and having according to said plat the following metes and bounds, to wit:

BEGINNING AT AN I. P. on the west side of Jones Avenue, joint corner of Lots 32 and 33, said pin also being 251.5 feet south from the southwest corner of the intersection of Jones Avenue and Crescent Avenue and running thence along the rear line of Lots 30, 31, and 32, S 84-40, W 238.2 feet to an I. P., thence S 5-41 E 61 feet to an I. P., thence with the line of Lot 34, N. 86-50 E 230.6 feet to an I.
