"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of McDaniel Avenue, in the City of Greenville, and being shown as Lot No. 25 on Map No. 2 of Cleveland Terrace, made by Dalton & Neves in May, 1931, andrecorded in Plat Book I at Page 86, and described as follows:

"BEGINNING at a stake on the Western side of McDaniel Avenue at corner of Lot No. 26, and running thence with the line of said lot, N. 75-55 W. 184.4 feet to a stake; thence N. 14-05 E. 70 feet to a stake at corner of Lot No. 24; thence with the line of said lot, S. 75-55 E. 182.7 feet to a stake on McDaniel Avenue; thence with the Western side of McDaniel Avenue, S. 12-58 W. 70 feet to the beginning corner."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
