NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 2 lots of land lying and being in Austin Township, located on the West side of a County Road off Jonesville Road, East of the Town of Simpsonville, being known and designated as Lots 14 and 15 on a plat of property of S. T. Holland, said plat made by J. Q. Bruce, Surveyor on October 14, 1949 and recorded in Plat Book. "W" Page 103, R. M. C. Office for Greenville County, and being more fully described as follows:
