To All Whom These Presents May Concern:

J. LOUIS COWARD CONSTRUCTION COMPANY, INC., SEND GREETING:

Whereas, the said J. Louis Coward Construction Company, Inc., a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to Central Realty Corporation in the full and just sum of Eight Hundred Thirty-three and 50/100 (\$833.50) Dollars, to be paid six months from date, with the privilege of anticipating payment at any time, said payment to be applied first to interest and then to principal

, with interest thereon from January 31, 1953, at the rate of 6 per centum per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 28 of a subdivision known as University Circle, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book Y at Page 111, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Blythwood Drive at the joint front corner of Lots 27 and 28 and running thence N 56-48 E 123.3 feet to a point at the joint rear corner of Lots 27 and 28; thence N 33-41 W 69.9 feet to a point at the joint rear corner of Lots 28 and 29; thence S 57-00 W 117.6 feet to a point on the Eastern side of Blythwood Drive at the joint front corner of Lots 28 and 29; thence with the Eastern side of Blythwood Drive S 29-21 E 70 feet to the point of beginning.
