WHEREAS:

MYRON EARL ELAM of Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

C. DOUGLAS WILSON & CO.

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand, Six Hundred Fifty and No/100 - - - - - Dollars (\$ 9,650.00), with interest from date at the rate of four per centum (4 %) per annum until paid, said principal and interest being payable at the office of C. DOUGLAS WILSON & CO. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty and 94/100 - - - - - Dollars (\$ 50.94), commencing on the first day of March, 19 53, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of February, 1978 .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville, State of South Carolina;

All that lot of land with the buildings and improvements thereon, situate on the southeast side of Gurley Avenue, near the City of Greenville, in Greenville County, S. C., being shown as Lot 43 on plat of Pickwick Heights, made by Dalton & Neves, Engineers, March 1950, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book X, at Page 141, said lot fronting 70 feet along the southeast side of Gurley Avenue and running back to a depth of 134.1 feet on the northeast side, to a depth of 134.9 feet on the southwest side and being 70 feet across the rear.

Also, one 110M BTU oil furnace with warm-air ducts to each room, 275 gallon fuel storage tank, one Wagoner TT Electric heater and one disappearing stairway located in the dwelling on the lot above described, which is hereby acknowledged to be a part of the mortgaged premises hereinabove described.

The above described property is the same conveyed to the mortgagor herein by deed of Roy Waters, of even date and to be recorded herewith.
