MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, B. J. Trammell

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Annie Whitmire Smith Burdine

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirteen Hundred and No/100

DOLLARS (\$ 1300.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$65.00 on March 1, 1953 and a like payment of \$65.00 on the 1st day of each month thereafter until paid in full, said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as lot No. 29 and the Western one-Half of lot No. 30 as shown on a plat of Perry Property, recorded in Plat Book I at Page 32, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southern side of Rogers Avenue, joint front corner of lots 28 and 29, and running thence with joint line of said lots, S. 5-50 E. 150 feet to iron pin; thence N. 83-55 E. 75 feet to an iron pin in center of rear line of lot 30; thence through center of lot 30, N. 5-50 W. 150 feet to an iron pin in Southern side of Rogers Avenue; thence with said Avenue, S. 83-55 W. 75 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by the mortgagee by deed to be recorded.

It is understood and agreed that this mortgage is junior in lien to a mortgage in the sum of \$5000.00 held by Fidelity Federal Savings & Loan Association.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
