Dollars (\$ 9100.00), with interest from date at the rate of four per centum (4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co.

in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-eight and 04/100 Dollars (\$ 48.04), commencing on the first day of

April, 19 53, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 19 78

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville in Gantt Township State of South Carolina;

being known and designated as Lot No. 297 of the property of Woodfields, Inc., a subdivision located on the southwest side of Augusta Road and having, according to a plat of said property made by Piedmont Engineering Service in August 1952 and recorded in the R. M. C. office for Greenville County in Plat Book DD at Page 27, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of South Beaver Lane at the joint front corner of Lots Nos. 296 and 297, which iron pin is 90 feet in a northwesterly direction from the intersection of Foxhall Road and South Beaver Lane and running thence along the line of Lot No. 296, N. 33-15 E. 92.7 feet to an iron pin; thence N. 20-0 E. 75.6 feet to an iron pin; thence N. 85-55 W. 93.4 feet to an iron pin; thence S. 33-15 W. 120.2 feet to an iron pin on the northern side of South Beaver Lane; thence along the northern side of South Beaver Lane S. 56-45 E. 100 feet to an iron pin at the point of beginning.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
