I, B. A. Fincher -WHEREAS, the said B. A. Fincher certain promissory note in writing of even date with these Presents, and truly indebted unto the Critzens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00). Dollars to me the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CTTIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the East side of Jones Road, North of U. S. Dual-Lane Highway No. 29, having the following courses and distances, to wit:-

Jones Road, set 16 feet from the center thereof, and corner of the Caldwell tract, and running thence along the Caldwell line, S. 86 E. 151.7 feet to iron pin; thence S. 22.18 E. 111 feet to iron pin; thence N. 86 W. 192 feet to center of Jones Road; thence along the center of Jones Road, N. 0.18 E. 110 feet to the beginning corner.
