Emma C. Poag all that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being comprised of three tracts and described as follows, to-wit:

Tract No. 1: All that parcel of land about one and one-half miles Southeast of the City of Greenville, being part of the Dickson Annex, formerly owned by Chas. T. Hammond beginning on a stone on the west bank of Reedy River and running thence S 46 W 15.00 to a stone on Butler Street; thence S 442 E 30.00 to Reedy River; thence up the meanderings of said River to the beginning corner and containing 42 acres, more or less, and more fully shown on a plat by W. A. Hudson, Dec. 1st,1891.

Tract No. 2: All that certain tract of land in Greenville Township, adjoining the above tract, being the tract deeded by G. A. Norwood to Mary J. Logan, July 25, 1896 and recorded in Vol. FFF, page 663, and having the following metes and bounds: Beginning at a stonein Butler Street and running with said Street S like E 30.00 to Reedy River; thence down said River to the Old Hammond Bridge Place; thence up the road to a stone near the River; thence N 15 W 8.80 to a stone; thence N 36 W 14.00 to a stone; thence the same degree continued to James M.
